TERMS OF USE

1. MISSION STATEMENT

It is our heart's desire to bless churches all around the world with this platform. True to the motto „share, inspire, equip“ ICF Zurich is providing for free all of its resources which were originally produced for church services of ICF Zurich. It is our prayer that you and your congregation may be blessed and inspired through these resources.

2. DEFINITIONS

- a. "Author" means the person or a group of persons who originally created the work.
- b. "Work" means the works of the author and any associated names or logos offered under this license.
- c. "You" means a person who registered on this platform for a free user account and is exercising rights under this license by agreeing to the terms of use.
- d. "Publicly perform" means to perform public recitations of the work and to communicate to the public those public recitations, by any means or process, to make works available to the public in such a way that members of the public may access these works from a place and at a place individually chosen by them.

ii. to provide audio and video message podcasts and videos on your church's websites.

iii. to make as many copies of the audio and video message podcasts and video files as you wish, give them away for free or to sell them at cost. – You are not allowed to make profit by selling audio and video message podcasts or videos.

b. Message slides, smallgroup program, message outlines, smallgroup booklet, powerpoint slides and graphics

i. to publicly perform this content in your church's ministries.

ii. to reproduce this content for use in your church's ministries.

iii. to use the content in the creation of derivative works, provided that the derivative works are used only in your church's ministries, and that the derivative works do not contain the logos of ICF Zurich anymore.

iv. to provide the content on your church's websites.

c. Promotional and other resources (materials other than audio and video message,

i. to publicly perform the promotional and other resources.

ii. to use the promotional and other resources to create derivative works without the logo of ICF Zurich.

iii. to reproduce and distribute copies of the promotional and other resources and derivative works.

iv. to upload and stream the promotional and other resources and derivative works from your church website.

The above rights may be exercised in all media and formats whether now known or hereafter devised.

5. RESTRICTIONS

The license granted in section 4 is limited by the following restrictions:

a. You may not use this work in any manner that is intended for commercial advantage.

b. You may not use this work without explicit permission of the licensor to show it on TV or play it on radio.

c. Except for members of the ICF Movement (check <http://www.icf-movement.org>), you may not use the logo of ICF Zurich, to represent your organization as ICF Zurich itself or affiliated with ICF Zurich. Nothing herein shall be construed to place the parties in a partnership or joint venture together, and you shall not have the right to bind or obligate ICF Zurich in any manner.
